Directions: From Albany: U.S. Hwy 19 north 8 mi. into Leesburg, right at light on Hwy 32/Main St. over RR tracks, straight through 2 stops signs, R at dead end on Starksville Ave. ½ block-park on side streets or in front of old gym and Chamber of Commerce.
